

**NOTICE OF PUBLIC HEARING FOR A  
PROPOSED COMMERCIAL SOLAR ENERGY FACILITY  
IN ADAMS COUNTY, ILLINOIS**

Pivot Energy IL 126 LLC is proposing to develop a 1.0 MWAC commercial solar energy project on approximately 8 acres of a 40-acre parcel of land located southwest of the intersection of North 1750<sup>th</sup> Avenue and East 1600<sup>th</sup> Street or south and west of Paloma, IL in Gilmer Township, Adams County, Illinois.

Pivot Energy IL 126 LLC is wholly owned by Pivot Energy, 1601 Wewatta St, Suite 700, Denver, CO 80202. The proposed facility will consist of equipment to generate electricity from solar energy and all solar panels and electrical equipment on site will be enclosed within a fence accessed via a locked gate. Pivot Energy IL 126 LLC is applying for a Special Use Permit pursuant to the requirements set forth in the Adams County Ordinance Regulating Commercial Solar Energy Facilities (Ordinance No. 2025-03-001-018).

In order to develop the property as proposed, approval of the Adams County Board must be granted to ensure that order is maintained, while also ensuring the protection of the health, safety and welfare of the residents of Adams County.

The Adams County Board will hold a public hearing on this request at 7:00 pm on Wednesday April 22, 2026, in the Adams County Board Room, Adams County Courthouse, 507 Vermont Street, Quincy, Illinois.

Every person in attendance at the hearing shall have an opportunity to be heard. The County shall allow interested parties to a Special Use Permit an opportunity to present evidence and to cross-examine witnesses at the hearing. The County may impose reasonable restrictions on the public hearing, including reasonable time limitations on the presentation of evidence and the cross-examination of witnesses. Every person who desires appearance for providing evidence and cross examination shall enter their request for appearance with the County Clerk no later than three (3) days before the date of the public hearing. The County shall also allow public comment at the public hearing in accordance with the Open Meetings Act. Any such electronic submissions must be received by noon (12:00 pm) on the day of the public hearing to be included in the public record.
